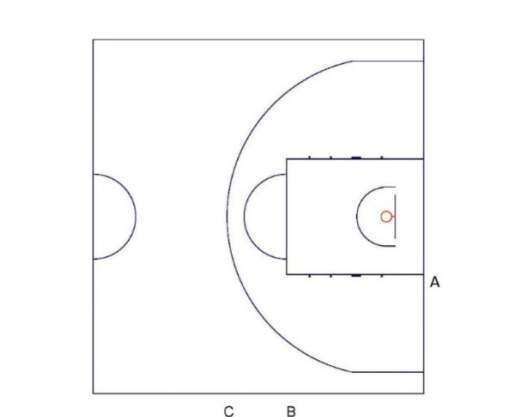


1. After ending their dribble, A1 takes three steps while fumbling the ball before regaining control of the ball. Is this a dribbling violation against A1?
2. A2 is fouled by B4 while in the act-of-shooting. The ball enters the basket. The referees deem that B4's foul was unsportsmanlike. The referees count the basket and award A2 one free throw followed by a throw-in for Team A at the throw-in line in Team A's frontcourt. Is this correct?
3. A1 is dribbling the ball in the frontcourt and then passes the ball to A2 who has one foot in contact with the center line and the other foot completely in the frontcourt. Is this a violation for illegally returning the ball to the backcourt?
4. Coach A is assessed a technical foul. Coach A then immediately requests a time-out. Is the time-out granted before the technical foul is administered?
5. During the opening jump ball, both A5 and B5 legally tap the ball. The ball bounces on the floor for 3 seconds when A3 and B4 create a held ball. How shall play resume?
  - A) Jump ball / A5 and B5 must jump / 10:00 on the game clock
  - B) Jump ball / A5 and B5 must jump / 9:57 on the game clock
  - C) Jump ball / A3 and B4 must jump / 9:57 on the game clock
6. With 53 seconds left in the 4th quarter A1 is holding the ball for a throw-in when A3 fouls B3 on the playing court. Shall the foul be automatically ruled an unsportsmanlike foul?
7. During the opening jump ball, jumper A2 taps the ball to A1 in their frontcourt and A1 starts to dribble. Shall the shot clock be set to 14 seconds for team A?
8. The ball is being passed between A1 and A3 when it is deflected by B1. The ball bounces and is then retrieved by B1 with both hands while standing stationary. B1 starts a dribble. Is this legal?
9. A1 is being closely guarded by B1 near the sideline. B1 has one foot in contact with the sideline when A1 touches B1. The referees award a throw-in to team B. Is this correct?
10. While airborne, A3 passes the ball to A4 who begins the act of shooting from the corner of the court. Before A4 releases the ball on the try for goal, A3 charges into B4 who has one foot in contact with the no-charge semicircle. The ball enters the basket. Shall the field goal count?
11. With 2:03 remaining in the 4th quarter, A5 scores a field goal. B2 takes the ball out of bounds for a throw-in with 2:00 remaining on the game clock. At this time, the timer stops the game clock. Is this correct?
12. During the opening jump ball, jumpers A1 and B1 both tap the ball. The ball hits the floor and then A1 catches the ball. Is this legal?
13. A1's shot for a field goal touches the ring and is rebounded by B1 while in the air. After B1 returns to the playing court, A2 then taps the ball out of B1's hands. A2 now retrieves the ball. Shall the shot clock be reset to 24 seconds?

14. Players A1 and B1 foul each other at approximately the same time. This is the third team A foul and fifth team B foul in the quarter. The referee calls a double foul and awards team A two free throws. Is this correct?
15. Team A requests a time-out followed by a team B request for a time-out. A1's shot for goal is successful. The referee blows the whistle and charges the time-out to team A. Is this correct?
16. A1 is holding the ball and then falls to the playing court. A1 slides and rolls before passing the ball to A2. Is this play legal?
17. A1 while dribbling charges into B1 who has established a legal guarding position. This is Team A's fifth team foul in the quarter. Shall B1 be awarded two free throws?
18. A1's lay-up attempt hits the backboard when defender B5 bats the ball away before the ball is completely above the level of the ring. Has B5 committed a goaltending violation?
19. With 3 seconds remaining on the shot clock. A5 attempts a try for goal. The ball becomes lodged between the ring and the backboard. The possession arrow favors team A. Team A is awarded a throw-in with 14 seconds on the shot clock. Is this correct?
20. Dribbler A1 is charged with a technical foul. B6 requests to enter the game to attempt the free throw. Is this permitted?
21. A1's try for goal hits the ring. B2 reaches through the basket from below and touches the ball while the ball is still in contact with the ring. Is this basket interference?
22. On the opening jump ball, A1 taps the ball directly out of bounds in Team A's backcourt. Team B is awarded a throw-in. The referee hands the ball to thrower-in B2. At this time shall the alternating possession arrow favor team A?
23. Are both head coach A and first assistant coach A permitted to remain standing at the same time in the team A bench area?
24. A4 commits a 3-second violation. Team B is awarded a throw-in. At which location will the throw-in be administered?



25. Shall each team warm-up prior to the game in the half court at the opponent's basket in front of their respective team benches?
26. Team B only has four players ready to play prior to the start of the game. Shall the referees start the game?
27. A1's try for goal is in the air when the horn sounds to end the quarter. After the horn has sounded, the ball is touched by B2 on its upward flight and then enters the basket. Shall the try for goal count?
28. A2 is dribbling the ball in the team A backcourt for 5 seconds when a technical foul is called against coach B. Shall team A have a new 8 second period to cause the ball to go into its frontcourt?
29. Assistant coach A enters the court to attend to injured A1. A1 is ready to play within 15 seconds. Must A1 be substituted?
30. With 21 seconds on the shot clock, thrower-in A5 passes the ball towards the team B basket and the ball touches the ring. Team A then immediately gains control of the ball. Shall the shot clock be reset to 14 seconds?
31. A1 is dribbling from the backcourt. A1's forward motions stops while both feet are in the frontcourt but the ball is being dribbled in the backcourt. Does the referee continue the 8 second count?
32. A2 begins the act of shooting and is fouled by B1. While airborne, A2 passes the ball to A1. This is team B's third foul of the quarter. Shall A2 be awarded free throws?
33. With 0:45 on the game clock and 18 seconds on the shot clock in the 4th quarter, Team A is awarded a throw-in in its backcourt near the center line. Team A is granted a time-out. After the time-out, head coach A requests that the throw-in take place in the backcourt. Before the ball is at the disposal of A3 for the throw-in, team B is granted a time-out. At the end of the team B time-out the head coach A now requests a frontcourt throw-in. Is this permitted?
34. A2 and B2 are standing next to one another in the free throw lane spaces. Free throw shooter A1 is holding the ball for the final free throw. Prior to A1's release, A2 steps into the restricted area followed by B2. A1 releases the shot and the free throw is not successful. The referees award team B with a throw-in at the free throw line extended. Is this correct?
35. A3 is fouled by B2 while in the act of shooting. The try for goal is successful. A3 then commits a technical foul. The referees count the basket by A3 and resume play with a throw-in to team B from the team B endline. Are the referees correct?

36. A1 is charged with an unsportsmanlike foul on B1. Team B is then granted a time-out. During the time-out, A2 is charged with a technical foul. After the time out B1 attempts 2 free throws with no line-up. Then any team B player shall attempt one free throw with no line-up. The game shall be resumed with a team B throw-in from the throw-in line in its frontcourt with 14 seconds on the shot clock. Is this correct?
37. A3 is in the backcourt and attempts a pass to A4 in team A's frontcourt. The ball hits A4 and deflects back into team A's backcourt where A3 gains control of the ball. Is this a legal play?
38. B1 fouls A1 and this is team B's fifth team foul of the quarter. A1 is awarded two free throws. Instead of A1 it is A2 who attempts the two free throws. The error is discovered after the successful second free throw. The referees cancel the two free throws and the game is resumed with a team B throw-in at the free-throw line extended in the team B backcourt. Is this the correct procedure?
39. With 18 seconds on the shot clock, B1 is charged with an unsportsmanlike foul on A1 in team A's backcourt. A2 is then charged with a technical foul. In which sequence shall play resume?
- A) A1 two free throws / Team B one free throw / frontcourt throw-in for Team A with 14 seconds on the shot clock
  - B) Team B one free throw / A1 two free throws / frontcourt throw-in for Team A with 14 seconds on the shot clock
  - C) Team B one free throw / A1 two free throws / throw-in for Team A nearest to where the unsportsmanlike foul occurred with 24 seconds on the shot clock
40. A1 sets a legal screen on B3 to free A2 for a three-point field goal attempt. After the release of the ball on the attempt, A1 fouls B3. The ball enters the basket. This is Team A's fifth foul of the quarter. The referees award three points to team A followed by two free throws to B3? Is this correct?
41. A1 and B1 begin a fight on the playing court. Team A manager and substitute A6 also enter the court and become actively involved in the fight. The penalties for A1 and B1 shall cancel and play shall be resumed with four free throws for any team B player followed by a throw-in for team B at the throw-in line in its frontcourt with 14 seconds on the shot clock. Is this correct?
42. A1's shot for a field goal is in the air when the shot clock signal sounds. The ball touches the backboard and then rolls on the playing court where neither team immediately controls the ball. The referees allow play to continue. Is this correct?
43. Near the end of the third quarter, A1 releases a shot for goal inside the two-point field goal area. Before A1 returns to the floor, A1 is fouled by B1 which is immediately followed by the game clock horn. The ball does not enter the basket. The referees determine that the foul occurred before the end of playing time, charge the foul to B1 and award two free throws to A1 with players occupying the free throw rebound places that they are entitled to occupy. A minimum of 0.1 seconds shall also be placed on the game clock. Is this correct?

44. A1 is in the act of shooting. Before the ball is released, B4 fouls A3. A1 finishes the shot with a continuous motion which started before the foul occurred and the ball enters the basket. The referees cancel the basket. Is this correct?
45. From Team A's backcourt, A2 passes the ball to A3. A3 gains control of the ball with one foot in the backcourt and one foot in the frontcourt. While holding the ball, A3 lifts the foot that is in the backcourt and then puts it back down in the backcourt. Shall a violation be called on A3 for illegally returning the ball to the backcourt?
46. During a pass from A1 to A2, B3 jumps in the air and deliberately strikes the ball with the fist. Is this a violation?
47. Dribbler A1 commits a traveling violation. B2 then fouls A2 before the ball is at team B's disposal for the throw-in. This is the fourth team B foul in the quarter. The referees resume play with a team A throw-in from the place nearest to where A1 committed the violation. Are the referees correct?
48. During a final free throw by A3, B4 leaps and taps the ball before the ball hits the ring. The referee awards one point to team A and resumes play with a team B throw-in on the endline. Is this correct?
49. A1 passes the ball from the backcourt to A2 who is in the team A frontcourt. A2 has a clear path to the basket with no player between A2 and the basket. B1 illegally contacts A2 from behind with both hands while the ball is in the air. Is this an unsportsmanlike foul?
50. A5's try for goal is in the air when the referee calls a foul on B4. After the whistle, the ball is rolling on the ring when B2 taps the ball away. Shall basket interference be called on B2?
